**MEMORANDUM OF UNDERSTANDING (MOU)
BETWEEN
NAVODAYA INSTITUTE OF TECHNOLOGY, RAICHUR
AND
GOVERNMENT FIRST GRADE COLLEGE, RAICHUR**

This MOU is entered into on the 04-03-2020 by and between Navodaya Institute of Technology, Raichur (hereinafter called NIT-R) situated at Raichur (Karnataka), and Government First Grade College, Raichur (hereinafter called GFGC-R), an UG/PG degree college affiliated to Gulbarga University, Raichur.

The aforesaid Institutions are hereinafter referred to individually as institute and collectively as institutes.

1. Objectives of the MOU

The objectives of the MOU are:

- To promote and enhance academic interest between NIT-R & GFGC-R.
- To provide advice for implementation of quality of education at GFGC-R.
- To promote research / continuing education activities between intuitions.

2. Technical Areas of Collaboration

- A continuing quality improvement program to improve quality of teaching staff at GFGC-R through short-term/ long-term certificate courses at NIT-R. Faculty of NIT-R could also be sent for GFGC-R for possible Guidance.
- Provide academic interaction by delivering special lecture at GFGC-R on topics of relevance to modern industry.
- Provide possible help in organizing workshops/conferences and personality development programs at NIT-R for enhancement of skills in respect of faculty, staff and students of GFGC-R.
- Provide possible support for establishment of video satellite link and assistance in development of E-class rooms, lab, curriculum, establishment of research labs, training and placement and library etc. at GFGC-R.

- e) Usage of academics infrastructure of NIT-R for GFGC-R students and faculty members.
- f) To facilitate the training for teachers and UG and PG students.
- g) Guidance for enhancement in infrastructural development of GFGC-R.
- h) Jointly supervision of PG thesis as per NIT-R norms.

3. Proposed Modes of Collaboration

NIT-R and GFGC-R propose to collaborate through the following


- a) Cooperation and promotion of education and training in areas of mutual interest.
- b) Any other appropriate more in interaction agreed upon between NIT-R and GFGC-R. A specific plan will be worked out by institutes depending upon availability of resources. A specific agreement will be entered into for each activity.


4. Terms and Conditions

- a) The cost of development infrastructure at GFGC-R should be borne by GFGC-R.
- b) For continuing education to GFGC-R teachers and students, the financial arrangements will be made mutually agreed terms.
- c) For the visits related to advice and consultancy, travel and other expenses of NIT-R faculty and staff shall be reimbursed by GFGC-R on mutual agreed terms.
- d) The faculty members and students of GFGC-R can use the library facility of NIT-R for short-time.
- e) Usage of NIT-R academic infrastructure can be allowed for limited period subject to its availability, approval of head of the faculty/department and institute norms.
- f) Both institutes agreed to help, identify and invite the faculty members and researchers from the other institutes to participate in conferences, workshops and short-term courses.
- g) This MOU may be amended, renewed and terminated by mutual written agreement of the institutes at any time.
- h) Either institute shall have the right to terminate these MOU upon 60 days prior written notice to the other institute.

5. Confidentiality

- a) The NIT-R and the GFGC-R agree to hold in confidence all information/data designated by the institutes as being confidential which is obtained from either institute or created during the performance of the MOU and will not disclose the same to any third party without written consent of the other institute.
- b) The above confidential clause under this MOU excludes the information/data possessed by either institute before entering into this MOU or independently developed and/or information already available through public domain.

6. Duration of MOU

This MOU, unless extended by mutual written consent of the institutes, shall expire in FIVE years after the effective date specified in the opening paragraph. However, on review, the MOU shall be extended for another TWO years by mutual consent.

7. Coordinators

Both institutes will designate persons who will have responsibility for co-ordination and implementation of this agreement.


8. Intellectual Property Rights


